Notice Of Discontinuation – Rapid Install ESFR Sprinklers Models ESFR-22 and ESFR-25

Effective November 15, 2024

Dear Colleagues and Business Partners,

This notice serves as a formal notification that the following products/part numbers have been DISCONTINUED in our systems. Accordingly, we will not be accepting new orders for these products/part numbers after November 15, 2024. Until that date, orders can be placed and will be fulfilled on a first-come, first-served basis, while supplies last.

To support existing systems, we will maintain a supply of RIS sprinklers, plugs, replacement gaskets, and adapters. These will allow standard NPT or ISO thread sprinklers to be used as replacements for the RIS sprinklers.

Customer FAQs:

1. Why is the Rapid Install being discontinued?

Johnson Controls has decided to reallocate our resources to support and enhance our traditional ESFR offerings.

2. Can I place a last-time buy for any Rapid Install product or accessory?

Yes, orders can be placed until November 15th, 2024. While quantities may be limited, and orders will be filled on a first-come-first served basis, we do expect to have enough inventory to fulfill all orders placed within this timeframe. However, if we deplete existing stock of a particular item, we will not be able to fulfill orders for that item.

3. I have a RIS system and may need to replace sprinklers in the future. How can I do that?

We will maintain a limited stock of RIS sprinklers and selected accessories to support repair and replacement for existing RIS systems. In most cases, if you need to replace a RIS sprinkler in the future, you can use an adapter (1" male RIS to female NPT or ISO), which will allow standard NPT or ISO thread sprinklers to work in a RIS welded outlet
